Exemption permit for removal goods

Instructions for use

This form is used to apply for an *Exemption permit for removal goods*. Such a permit allows you to import goods into the Netherlands exempt from taxation. The goods in question are destined for the Netherlands or another country of the European Union.

Conditions

To obtain the permit you must fulfil the following conditions:

- You are moving from a country outside the European Union to the Netherlands, and you are going to live in the Netherlands or another country of the European Union. You are thereby transferring your habitual residence to the European Union.
- You lived outside the European Union for at least twelve consecutive months.
- You have owned and used the goods for at least six months.
- You have used the goods and are going to use them again.
- You are importing the goods within twelve months of coming to live in the Netherlands or another country of the European Union.
- You are not going to lend out, pledge, hire out or transfer ownership of the goods within the first twelve months after the date on which they were imported.

The exemption does not apply to the following goods:

- alcoholic beverages
- tobacco and tobacco products
- commercial vehicles
- non-portable materials for business purposes.

Are you also importing a means of transport? You should specify this in question 5. Is the means of transport a car or motorcycle? And is that vehicle exempt from tax on import? In that case you should obtain two separate permits, one for the goods and one for the car or motorcycle.

Enclosures

The following documents should be enclosed with your application:

- a copy of your passport, including your visa if necessary
- proof of registration in the municipal personal records database
This document should show you have taken up residence in the Netherlands or another country of the European Union, and the date on which you did so. You may also send some other, comparable document which provides reasonable evidence for this purpose.
- two signed lists of goods
State the goods you wish to import on this list.
- invoices, proofs of guarantee etc. for the goods you wish to import (commercial documents)

Enclose copies of any documents which show you are going to live in the European Union. For example:

- your employment contract
- your employer's statement
- your work permit
- your tenancy or purchase agreement for the home you plan to live in

Do you want to import a car, motorcycle or some other means of transport? In that case enclose a copy of:

- the vehicle registration certificate
- the receipt or proof of ownership

Answer the questions in full. You may also use this form to report any changes in your situation. In that case answer only question 1 and the question or questions to which the changes relate. If there is not enough space to finish answering a question, you should continue your answer on an extra enclosure.
